**e-TENDER CONDITIONS FOR SUPPLY OF GLUCONATED NANO FERTILIZER**  
**2015 SEASON**

Competitive e-tenders are invited for the the supply of organic manure in the category of **NANO N P K GRANULE (GLUCONATED) with N-P2O5-K2O-minimum 4:4:4 percentage along with AMINO ACID-minimum 6%** The quantity required is **126500 kg** for Cashew Plantations as mentioned in clause 17 of this tender condition. The supply should be effected within the period specified in the purchase order. The tender should accompany Earnest Money Deposit equivalent to 1% of total cost of each material quoted.

1. The quantity shown in the schedule is only approximate and the supplier will have to supply the entire as mentioned in the Purchase Order.
2. The rate to be quoted by the tenderer should be for the supply at this unit shown in the schedule. The rate should include all taxes, duties, Cesses , transporting - loading and unloading charges for the supply of the items to the various places mentioned in clause 17. The rate should be firm till the supplies are over. No price variation clause will be entertained. The conditions printed or otherwise added to the tender will not be binding on the Corporation.
3. The supply should be made in packets having 25 kgs.
4. The period for supply of the material should be strictly adhered to. No extension of period will be allowed in the ordinary course. For delayed supply if any , penalty at the rate of ½% of the cost of the material to be supplied can be realised for every seven days of extension upto one month maximum. For less than seven days, proportionate penalty will be realised.
5. If the tenderer withdraws from his offer before the expiry of the period of supply, the Corporation may arrange purchase of the item as a whole or part thereof at any rate and the losses and expenses thus incurred on this account will be realised from the tenderer apart from forfeiting the EMD/Security Deposit.
6. The acceptance of the tender rests with the Managing Director who does not bind himself to accept the lowest rate or any other rate. But the tenderers on their part should be prepared to carry out such portion of the supplies included in their tenders as may be allotted to them as per the Purchase Order.

7. Communication of acceptance of the tender constitutes a concluded contract. Nevertheless the successful tenderer shall also execute an agreement in the Kerala Stamp Paper worth of Rs. 500/-. A Security Deposit equivalent to 5% of the contract (including EMD) should be made before executing the agreement. Time is the essence of the contract.
  
8. The contractor shall not assign, make over, underlet or sublet the contract to any person or firm or body corporate.
  
9. In case the contractor fails to make the supply of the entire quantity of the material or after having supplied part of the quantity, fails to fulfill the contract in full, all or any of the material not supplied may at the discretion of the Managing Director, be purchased by means of another tender/quotation or by negotiation or from the next highest tenderer, and the resultant losses and expenses if any, sustained to the Corporation together with such amount as may be fixed by the Managing Director towards the cost of damages be realised from the defaulting contractor and the EMD and Security Deposit shall be forfeited. Such decision of the Managing Director shall be final and shall not be called in question. Even in the case where no alternate purchases are arranged for materials not supplied, the EMD and Security Deposit of the contractor can be forfeited.
  
10. All payments to the contractor will be made by cheque/RTGS only. 50% of the payment for the supply made will be effected after getting Stores Receipt Note and Original Invoice from concerned estates. The final settlement will be effected after receiving the test report from the Estate Managers. The Contractor will send the original invoice to the concerned estate with copy to Head Office.

The following certificate duly signed and sealed by the Contractor with date is to be furnished along with the invoices.

“Certified that the goods in which Sales Tax has been charged have not been exempted under the Central Sales Tax Act or the State Sales Tax Act or the Rules made thereunder and the charges on account of Sales Tax on these goods are correct under the provisions of the relevant Act or the Rules made thereunder. 11. . EMD equalent to 1% of the total amount in the form of Demand Draft drawn in favour of The Plantation Corporation of Kerala Limited, payable at Kottayam should be submitted within the time mentioned and a scanned copy of the Demand Draft should be attached along with the e-tender. The Security Deposit (rounded to the nearest next rupee) should be submitted in the form of demand draft drawn in favour of The Plantation Corporation of Kerala Limited, payable at Kottayam only.

12. The EMD of the unsuccessful tenderers will be refunded within 30 days of the finalisation of the tender. The Security Deposit of the Contractor will be refunded after the completion of the contract.

13. In case any difference or dispute arises in connection with the contract, all legal proceedings relating to the matter shall be instituted in the Courts having jurisdiction at Kottayam only.

14. No interest will be given for EMD/Security Deposit.

15. The Corporation will have the right and liberty to distribute the quantity among two or more suppliers, if so found necessary.

16. As this is a sealed competitive tender, normally negotiation will be held with the lowest quoted party [sample approved]. But if the company felt that the rate quoted by the lowest party is not reasonable or if the company desires to have a contract with more than one supplier the company has the right to negotiate with any of the other parties participated in the tender.

18. Two samples weighing 100 gms each should accompany the quotation which shall be tested at Rubber Board Laboratory. Random samples shall be taken from the manure supplied and the same shall be tested and compared with the result of the approved sample. Consignments which do not confirm to the approved sample would be rejected outright.

19. Manure should contain only nano NPK granule (gluconated) with N- P<sub>2</sub>O<sub>5</sub>- K<sub>2</sub>O- Minimum 4-4-4 along with amino acid-minimum 6%

**20.** Cost of tender form of Gluconated nano fertilizer is Rs . 11450 /-(Including tax) and should be submitted through online link in the website while submitting the tender. Otherwise tender could not be valid and hence can not be considered.

21. The last date and time of submission of the bid for Gluconated Nano fertilizer is 5 PM on 31.07.2015. Tender should accompany the following

- i. Offer showing the rate for supply of material.
- ii. EMD equivalent to 1% of the total amount. Demand Draft for the same is to be scanned & submitted along with the tender and original Demand Draft should be produced at Purchase Department on or before 05.08.2015, 1 PM.
- iii. Tender conditions duly signed in all pages in token of having accepted the same.
- iv. Sample as per the schedule should be produced on or before 05.08.2015, 1.00 PM.
- v. Test report of the material from recognized lab approved by Rubber Board should be attached along with the tender

The tenders will be opened at 2.30 p.m. on 05.08.2015, in the presence of intending tenderers and their authorized representatives, if present.
